## SECTION 4: First aid measures

### 4.1 Description of first-aid measures

#### General advice

First aiders need to protect themselves. Show this material safety data sheet to the doctor in attendance.

#### If inhaled

## **5.2 Special hazards arising from the substance or mixture**
