If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

Absorption, Distribution and Excretion

Eighty-eight percent of radiolabel from (14)c-labeled propionyl erythromycin lauryl sulfate excreted in urine in 24 hr following single oral dose. more than 95% was butyric acid 4-sulfate, a derivative of lauryl sulfate moiety.

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

12.2 Persistence and degradability

Surfactants are treated with pseudomonas to decompose them in wastewater. If 2102 bacteria culture was treated with soln containing 1000 ppm dodecyl alcohol sulfate. decomp was 100%.

12.3 Bioaccumulative potential

An estimated BCF of 71 was calculated for dodecyl sulfate(SRC), using an estimated log Kow of 2.4(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is moderate.

12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc for dodecyl sulfate can be estimated to be 1.0X10+4(SRC). According to a classification scheme(2), this estimated Koc value suggests that dodecyl sulfate is expected to be immobile in soil.

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
