11.2 Additional Information

To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.

For additional studies related to this product, review OSHA literature on Diacetyl and flavorings (www.OSHA.gov), the OSHA NEP for Microwave Popcorn Processing Plants, NIOSH publication 2004-110d, and other NIOSH literature regarding flavorings (www.cdc.gov/NIOSH). Animals exposed to diacetyl and other related diacetyl substitutes experienced damage to the nose and upper airways, including severe damage to cells lining the respiratory tract. NIOSH has reported that employees exposed to butter flavorings containing diacetyl are at risk of developing occupational lung diseases and that in one instance, similar illnesses have been found among employees producing butter and vanilla flavorings containing diacetyl.

Hazardous properties cannot be excluded but are unlikely when the product is handled appropriately.

Other information

The following applies to ketones in general: when vapours/aerosols occur, mucosal irritations, coughing, and dyspnoea after inhalation. The absorption of large quantities leads to: CNS depression (narcosis). Repeated skin contact leads to a degreasing effect, with secondary inflammation possible. Toxic effects on the liver and kidneys cannot be excluded after high doses. The inhalation of droplets may result in the formation of oedemas in the respiratory tract.
