6. Accidental release measures

Personal Precautions	Ensure adequate ventilation. Use personal protective equipment as required. Keep people away from and upwind of spill/leak. Evacuate personnel to safe areas. Remove all sources of ignition. Take precautionary measures against static discharges.
Environmental Precautions	Should not be released into the environment. See Section 12 for additional Ecological Information. Avoid release to the environment. Collect spillage. Do not flush into surface water or sanitary sewer system.

Methods for Containment and Clean Up Soak up with inert absorbent material. Keep in suitable, closed containers for disposal. Do not expose spill to water. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment.

7. Handling and storage
