6. Accidental release measures

12.1 Toxicity

12.2 Persistence and degradability

AEROBIC: By analogy to chemically similar long chain fatty acid esters that were rapidly degraded by mixed sewage sludge(1,2,3), isobutyl stearate is expected to rapidly biodegrade under aerobic conditions(SRC).

12.3 Bioaccumulative potential

An estimated BCF of 3 was calculated for isobutyl stearate(SRC) using an estimated log Kow of 9.63(1,SRC) and a regression-derived equation(2). According to a classification scheme(3), the estimated BCF suggests the potential for bioconcentration in aquatic organisms is low.

12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc for isobutyl stearate can be estimated to be about 33,000(SRC). According to a classification scheme(2), this estimated Koc value suggests that isobutyl stearate is expected to be immobile in soil.

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
