We have no description of any toxic symptoms.

The following applies to aromatic amines in general: systemic effect:

methaemoglobinaemia with headache, cardiac dysrhythmia, drop in blood pressure, dyspnoea, and spasms, principal symptom: cyanosis (blue discolouration of the blood).
