7.1. Precautions for safe handling.

Keep away from heat, sparks and naked flames; do not smoke or use matches or lighters. In order to avoid the risk of fires and explosions, never use compressed air when handling. Open containers with caution as they may be pressurised.

RESPIRATORY PROTECTION

(see standard EN 14387). In the presence of gases or vapours of various kinds and/or gases or vapours containing particulate (aerosol sprays, fumes, mists, etc.) combined filters are required.
