Specific Hazards Arising from the Chemical

7. Handling and storage**Handling**

Wear personal protective equipment/face protection. Do not get in eyes, on skin, or on clothing. Use only under a chemical fume hood. Do not breathe mist/vapors/spray. Do not ingest. If swallowed then seek immediate medical assistance. Do not allow contact with water. If peroxide formation is suspected, do not open or move container. Storage
