If inhaled

12.3 Bioaccumulative potential

Based on an estimated log Kow of 6.37(1, SRC), the BCF of diphenyl octyl phosphate is estimated as 41000 from a regression-derived equation(2, SRC). Using an experimental water solubility of 0.14 mg/L(3), a BCF of 1900 is calculated for diphenyl octyl phosphate(2, SRC). These BCF values indicate that bioconcentration of this compound in aquatic organisms is an important fate process for diphenyl octyl phosphate(SRC). However, depuration of many phosphate esters is rapid due to metabolism at the ester functionality; thus, these BCF values may not reflect what is seen in the environment(4, SRC).

12.4 Mobility in soil

Based on an experimentally derived water solubility(1) and a regression-derived equation, the Koc of diphenyl octyl phosphate was estimated as 13000(2, SRC). Using an estimated Kow of 6.37(3), the Koc for octyl diphenyl phosphate was estimated as 70000(2). According to a suggested classification scheme(4), these Koc values indicate that diphenyl octyl phosphate will be immobile in soil(SRC). Hydrolysis of diphenyl octyl phosphate may occur while this compound is bound to the soil(5).

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
