4.1. Description of first aid measures

Note to physician: Organochlorogermanes react with water to form hydrochloric acid, consequently treatment for acid burns may be considered.

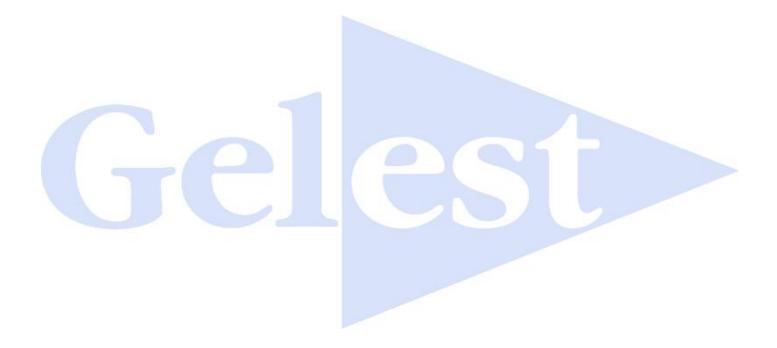
