Acute poisoning results in swelling of the feet and legs, arthralgia, vomiting, insomnia, hyperesthesia and paresthesia of the hands and feet, mental confusion, polyneuritis with severe pain in the legs and loins, partial paralysis of the legs, angina-like pains, nephritis, wasting and weakness, and lymphocytosis and eosinophilia. In chronic poisoning, central and peripheral nervous system abnormalities may persist including ataxia, tremor, incoordination, paralysis of extremities, endocrine disorders, memory loss, and psychoses may develop., To the best of our knowledge, the chemical, physical, and toxicological properties have not been thoroughly investigated.
