Methods for Containment and Clean Up Soak up with inert absorbent material (e.g. sand, silica gel, acid binder, universal binder, sawdust). Keep in suitable, closed containers for disposal. Wear self-contained breathing apparatus and protective suit. Do not expose spill to water. Do not let this chemical enter the environment.

7. Handling and storage

Handling Do not get in eyes, on skin, or on clothing. Remove and wash contaminated clothing and gloves, including the inside, before re-use. Avoid breathing vapors or mists. Do not ingest.
